I am the holder of 40 shares of AGC Networks Ltd.

I had initially purchased the 20 shares that had been allotted to me.

Subsequently, in 2012, I was allotted 20 Bonus shares, on 1:1 basis.

When I had made my initial purchase of shares, I was working in Mumbai, and staying with my mother at the following address -

"Flat D-010, HRUSHIKESH, Apna Ghar CHSL (Unit 1), Lokhandwalla Complex, Andheri (W)".

The 20 shares purchased by me then, were also kept in my above residence.

However, subsequently, I moved out of Mumbai on work, and after moving to various cities in the course of my work, finally bought my own flat in Bangalore and settled down there. My mother however preferred to stay on in Mumbai as Bangalore's climate did not suit her health, due to her asthmatic problems. My originally purchased 20 shares also continued to be kept there, since I forgot to intimate my changed address to AGC Networks or Datamatic Solutions.

Thus, the 20 bonus shares were also received and kept in Mumbai by my mother. I forgot all about the existence of these shares and realized their presence only when I lost my mother recently, and came across the bonus shares envelope, that was kept unopened in my documents file in Mumbai!

I could not however, locate the originally purchased 20 shares among the other documents there.

I have attached the following documents in support of my above claim -

1. The scans of both the front and back of the envelope in which the bonus shares were delivered to my above address.

2. The scan of the covering letter that accompanied the bonus share certificate, which mentions the presence of the original allotment of 20 shares.

3. The scan of the Bonus Share certificate, with distinctive numbers 0028445995 to 0028446014.
